Dear Entran II Property Owner:

The enclosed Notice of Expanded and Modified Settlement is being sent to you because you have previously excluded yourself and/or filed a separate lawsuit from the class action filed in the United States District Court for the District of New Jersey known as Galanti v. The Goodyear Tire & Rubber Company, Civil Action No. 03-209.

Enclosed for your attention and consideration is the Notice of Expanded and Modified Settlement. **You have the right to re-join the expanded and modified class** and participate in this Amended Settlement.

Under this Amended Settlement Agreement, if you own or owned a property where Entran II rubber hose made by The Goodyear Tire & Rubber Company was or is installed as part of a radiant heating or snowmelting system, you may be eligible for compensation even if you would not have been able to obtain compensation under the earlier settlement, if you file a timely claim.

Your rights and the details of the Amended Settlement Agreement are more fully described in the accompanying Notice of Expanded and Modified Settlement.

The enclosed forms are: (1) a "Request to Re-Join" postcard; (2) the Notice of Expanded and Modified Settlement; (3) the Amended Plan of Distribution and Allocation; and (4) a Claim Form. The Court will consider the proposed Amended Settlement at a Fairness Hearing scheduled for October 19, 2004. You are not required to attend the Hearing. 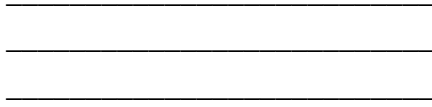
